Old School Sports Group (Pty) Ltd & Circle Way Trading (93) (Pty) Ltd (“the Companies”) respects consumers’ constitutional rights to privacy and data protection. Accordingly, the Companies believe in protecting the personal information we collect from you when you use our various event entry websites – www.capetown.10s.co.za, www.durban.10s.co.za, www.tshwane.10s.co.za, www.10s.co.za (“Websites”). The Companies will use its best commercial endeavours to only use or disclose your personal information in the manner stated in this policy.

This privacy policy forms part of the Website’s terms and conditions.

1 Personal information

Personal information refers to all information about you as an identifiable individual, including your name, residential and postal address, e-mail address, telephone number and identity number.

1.1 Personal information collected

- a) Limited personal information is collected using cookies. A cookie is an alphanumeric identifier which we transfer to your hard drive through your web browser when you visit our Websites. It enables our own system to recognise you when you visit our Websites again and to improve our service to you. Cookies may also be used to compile aggregate information about areas of our Websites that are visited most frequently. This information can be used to enhance the content of our Websites and make your use of it easier. We do not monitor which pages you looked at while visiting our Websites. You can disable our use of cookies by configuring your browser accordingly.
- b) In order to register for certain services or enter our events offered through our Websites the Companies will from time to time ask you for relevant personal information. The Companies will use such information to provide the services to you. The Companies may also use such information for its own internal purposes including–
 - i. establishing and verifying your identity;
 - ii. maintaining and updating our customer databases;
 - iii. communication of Event sponsor marketing and advertising material; and
 - iv. personalised marketing, product research and development purposes.

1.2 Storage of personal information

The Companies use all reasonable endeavours to put in place and maintain electronic procedures and systems to ensure accuracy and to prevent unauthorised access to your personal information with reference to accepted technological standards.

1.3 Personal information shared

- a) The Companies will not sell, licence or otherwise disclose your personal information to any third party without your consent, provided that by using our Websites and/or subscribing for any of our services, you provide your express and informed consent for the Companies to disclose your personal information to third parties as follows:
- i. to third party companies employed by the Companies to provide services for us, including for example, website hosting and development. These companies require access to your personal information to perform their functions and not for any other purposes;
 - ii. to transfer the Companies' customer database/s, including personal information contained therein, to any third party who may acquire all or substantially all of the assets or shares in the Companies or our website service whether by sale, merger, acquisition or otherwise;
 - iii. to governmental agencies, exchanges and other regulatory or self-regulatory organisations if the Companies are required to do so by law or if we believe that such action is necessary to:
 - comply with the law or with any legal process;
 - protect and defend our rights and property or that of our customers and the Companies or other entities within our group;
 - prevent fraud or abuse, misuse or unauthorised use of our Websites; and/or
 - protect the personal safety or property of our customers or the public (if you provide false or deceptive information about yourself or misrepresent yourself as being someone else, the Companies will disclose such information to the appropriate regulatory bodies and commercial entities).
- b) The Companies reserve the right to share non-personal, non-individual information in aggregate form with third parties for business purposes, for example, with advertisers on our website or business associates and partners. This does not involve disclosing any personal information which can identify any individual consumer in any way.

2 Legal Disclaimer

- 2.1 We reserve the right to disclose your personally identifiable information to governmental bodies, exchanges and other regulatory or self-regulatory organisations if the Companies are required to do so by law or if we believe that such action is necessary to protect the Companies from any potential liability.
- 2.2 In addition, we may disclose information if required to do so to any regulatory authorities in connection with any investigation of fraud, intellectual property infringements or other activity that is illegal or may expose the Companies to legal liability.
